Stay Abreast of Telehealth Regulations

In September, the Maryland Department of Health launched a pilot program aimed to increase access to telemental health services, including behavioral health care and substance use disorder treatment. Local behavioral health authorities have selected providers who will receive the funds to purchase HIPAA-compliant telehealth devices.
