When paired with the 11% renewal dividend declared by the MEDICAL MUTUAL Board of Directors, this means that we can once again keep the amount billed for your renewal policy unchanged for the coming year. In other positive news, this past summer the Maryland Court of Appeals ruled against making a change to the doctrine of contributory negligence. The ramifications of changing this long-standing personal injury law could have potentially meant an increase in litigation against Doctors, as well as a spike in overall litigation costs.

Large settlements are still affecting health care providers across the country, and new challenges continue to present themselves. This includes an increase in mass tort claims, such as the tainted steroid matter in New England, and the actions alleging improper stent usage.

2014 Renewal Premium to Remain Unchanged

MEDICAL MUTUAL will not be filing for a rate increase in 2014. In addition, the Board of Directors has approved an 11% dividend credit for 2014 renewal policies. The combination of these two actions should result in no increase in the premium you pay for the coming year, absent any other changes that may affect your price, such as claims-made step increases or other policy coverage changes.

The current rate stability for 2014 can be attributed to a continuing moderation in claims frequency, as well as the company's overall stable financial position. In order to receive the credit, a Policyholder must have had a policy in force by MEDICAL MUTUAL and be renewing in 2014. Maryland High Court Rules in Favor of Personal Injury Law

In July, the Maryland Court of Appeals ruled to keep in place the doctrine of contributory negligence – a law which bars a plaintiff from recovering damages in a lawsuit if the plaintiff contributed to his or her own injury in any way. In a 5-2 decision, the high court opted not to change the common-law doctrine, citing the nearly 166-year-old precedent and saying that the decision to make a change to the law must come from the General Assembly.

The case involved a then 20-year-old soccer coach who jumped up to hang from the metal crossbar of a soccer goal. The goal was unanchored and tipped over, crushing bones in the plantiff's face. The plaintiff sued the Soccer Association of Columbia. The Court determined that the association was at fault for not securing the goal, but that the plaintiff also was partially responsible for the accident due to his actions. A change in the negligence standard could have potentially led to increased rates for liability insurance and a spike in frivolous lawsuits.
